I. FINANCIAL REPORT

Checking: \$ 3739.49

Grant: \$ 20,000

- Final invoice submitted to Drug & Alcohol Commission for \$7,111.60. Had a balance of approximately \$896.00. Bought \$100.00 gas card for taxi & pens with lights & stylus for Law Enforcement Seminar. Less than \$10.00 left.
